VIETNAM'S RUBBER EXPORT VALUE SEES SURGE IN FOUR MONTHS

Vietnam exported 486,000 tonnes of rubbers worth 817 million USD in the first four months of 2021, up 79.6 percent in volume and 111.6 percent in value compared to the same period last year, according to the MARD.

In April alone, the country shipped an estimated 80,000 tonnes of rubber abroad, earning 143 million USD. China, India and the US were the largest importers of Vietnamese rubber in the first three months of the year, accounting for 64.2 percent, 5.1 percent, and 2.7 percent of Vietnam's total export volume. The export price of rubber reached averagely 1,660 USD per tonne in the first three months of the year, up 14.1 percent year-on-year.

Vietnam has the fifth largest rubber cultivation area in the world, but its output ranked third, only after Thailand and Indonesia. It has exported mainly raw material of latex, accounting for about 78.4 percent. The rest (21.6 percent) has been processed products such as tires, gloves, accessories and soles of shoes./.

LAO CAI'S CINNAMON PRODUCTS EXPORTED TO NINE COUNTRIES

Cinnamon products of Tam Hoi Cooperative in the northern mountainous province of Lao Cai are now exported to 9 countries, including: Singapore, India, Thailand, Malaysia, Bangladesh, Qatar, Lebanon, Israel, and Turkey, reported VOV News. Annual revenue from cinnamon exports is about 80-90 billion VND.

Over the past month, through Vietnam Tropical Products One Member Limited Liability Company, Tam Hoi Cooperative has exported over 100 tons of cinnamon sticks to Singapore, India and Thailand at the price of 120,000 VND per kilogram.

All boxes of cinnamon products for the first time have clearly labelled the origin of Lao Cai. Earlier, most of the units and businesses that were purchasing cinnamon in Lao Cai invested in building processing factories in Yen Bai, thus the exported products previously had the Yen Bai geographical indication.

Therefore, specialized agencies have advised the province to direct localities to focus on building the Lao Cai cinnamon brand./.
